Professional Experience

Ajmalul Hossain K.C. read law at King's College, University of London gaining a Master's Degree in 1977. He is a founder member of Selborne Chambers in London from where he practises as Queen's Counsel and a Senior Advocate of the Supreme Court of Bangladesh and Senior Partner of A Hossain & Associates in Bangladesh, Singapore, Geneva and Dubai.

Ajmalul has over 40 years experience in dispute resolution and is an experienced advocate in multiple jurisdictions appearing before the High Court and Court of Appeal in London, the High Court and Appellate Divisions of the Supreme Court of Bangladesh and in domestic and international arbitrations and mediations. He has provided expert opinions on the laws of England, Bangladesh, India, Pakistan, the European Union and Singapore and sits on disciplinary panels and tribunals. He is the current Chairman of the Bangladesh International Football Federation.

Ajmalul also regularly advises the Bangladesh Government and Parliament on constitutional issues and the Law Commission on constitutional, commercial and dispute resolution issues.
